<b>PERSONAL ASSISTANCE COVID-19 Disaster Payment</b>	<ul style="list-style-type: none"> <li>Individuals living in NSW</li> <li>Individuals who have lost &gt; 8 hours or a full day's work a week</li> </ul>	<ul style="list-style-type: none"> <li>Lost 8 - 20 hours \$375/week (was \$325)</li> <li>Lost &gt;20 hours \$600/week (was \$500)(Ongoing Payment) (Ongoing Payment)</li> </ul>	<ul style="list-style-type: none"> <li>Apply through Services Australia</li> <li>Individual eligibility criteria apply</li> </ul>
<b>Pandemic Leave Disaster Payment</b>	<ul style="list-style-type: none"> <li>If NSW Health has told you to self-isolate or quarantine for 14 days</li> <li>You have COVID-19</li> <li>You are a close contact of someone with COVID-19</li> <li>You are caring for someone with COVID-19</li> <li>You are over 17 years old</li> <li>You have no leave entitlements</li> </ul>	<ul style="list-style-type: none"> <li>\$1,500 for each 14 day period of isolation (One-off payment)</li> </ul>	<ul style="list-style-type: none"> <li>Apply through Services Australia</li> <li>Individual eligibility criteria apply</li> </ul>
